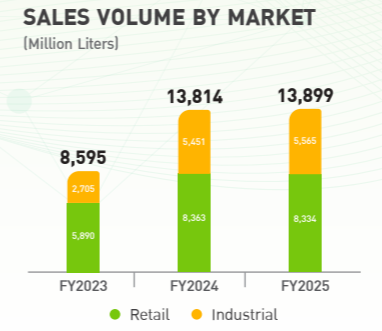
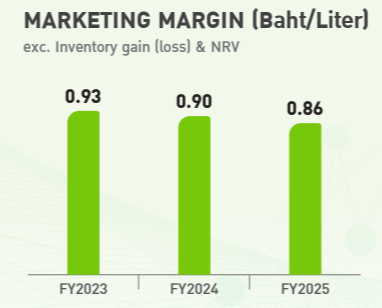
## ACCOUNTING EBITDA BY BUSINESS (% OF TOTAL EBITDA)



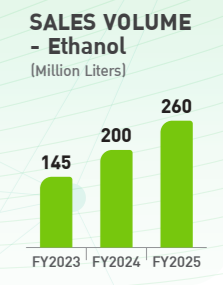
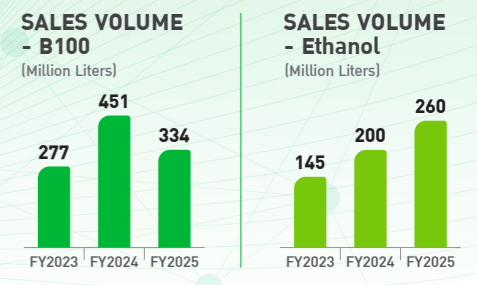
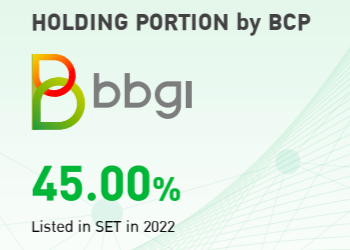
