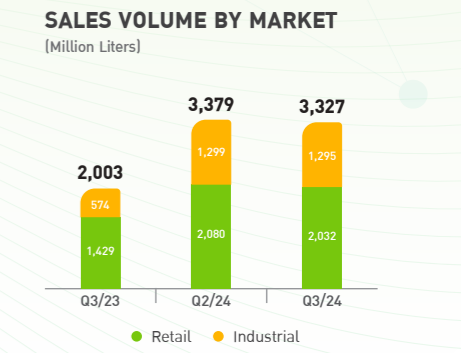
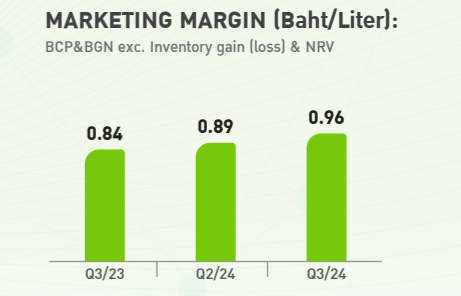
## REFINERY AND OIL TRADING BUSINESS GROUP



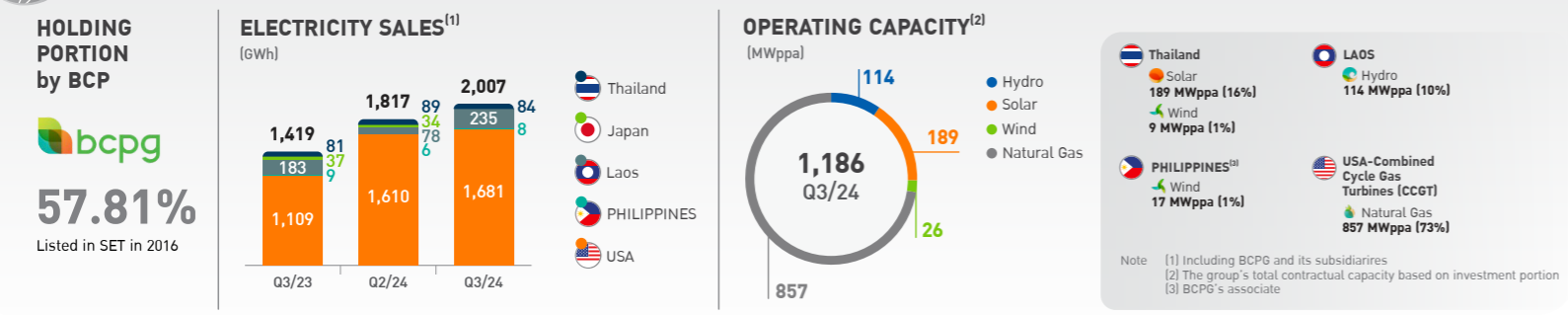
### ACCOUNTING EBITDA BY BUSINESS (% OF TOTAL EBITDA)



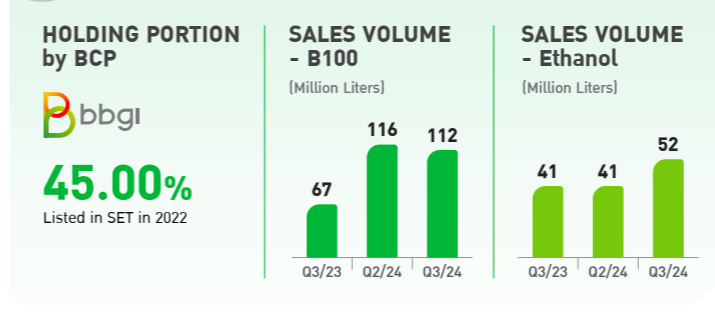

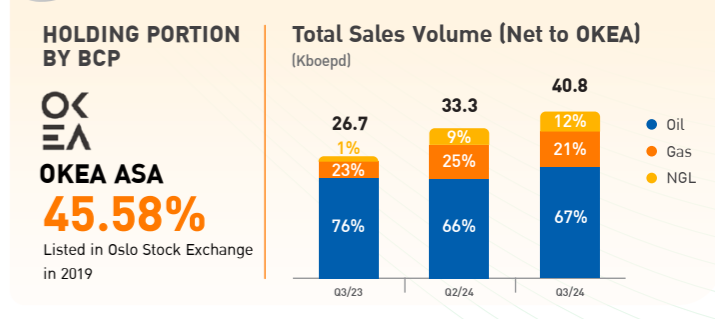
